1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Surveilling Effluent
- 3 Water for Epidemic Response Act" or the "SEWER Act".
- 4 SEC. 2. NATIONAL WASTEWATER SURVEILLANCE SYSTEM.
- 5 (a) IN GENERAL.—Subtitle C of title XXVIII of the
- 6 Public Health Service Act (42 U.S.C. 300hh–31 et seq.)
- 7 is amended by adding at the end the following:
- 8 "SEC. 2827. NATIONAL WASTEWATER SURVEILLANCE SYS-
- 9 **TEM.**
- 10 "(a) National Wastewater Surveillance Sys-
- 11 TEM.—The Secretary, acting through the Director of the
- 12 Centers for Disease Control and Prevention, and in coordi-
- 13 nation with Federal departments and agencies and rel-
- 14 evant State and local departments and agencies, shall ex-
- 15 pand, intensify, and coordinate the activities of the Na-
- 16 tional Wastewater Surveillance System to detect and mon-
- 17 itor pathogens in wastewater, such as SARS-CoV-2, in-

- 20 "(b) Authorization of Appropriations.—To

- 24 (b) Rule of Construction.—Nothing in the
- 25 amendment made by subsection (a) shall be construed as

- 1 requiring a wastewater utility or service provider to com-
- 2 ply with a request for wastewater surveillance.
